The obligation of the Surety shall, in no event, exceed the penal sum hereof unless the Surety has expressly consented to any change, modification or extension of the AGREEMENT and has issued its written adjustment of the penal sum, signed by the APPLICANT and Surety.
- 3. Upon failure of the APPLICANT to perform any of the terms of the AGREEMENT, The Surety shall either perform the terms of the AGREEMENT or shall tender to the City the amount which the City estimates necessary to effect compliance with the terms of the AGREEMENT. The City estimate may not be challenged or otherwise disputed by the APPLICANT or Surety. Any funds provided by the Surety in excess of that expended to remedy noncompliance with the AGREEMENT will be returned to the Surety upon completion of the remedial work and payment of outstanding fees.
- 4. The City of Sammamish may transfer its rights and obligations under this Surety Bond and the associated AGREEMENT to any successor jurisdiction without notice to the Surety or APPLICANT. The rights and obligations under this Surety Bond are for the exclusive benefit of The City of Sammamish. Except as otherwise expressly provided herein, the rights and obligations of The City of Sammamish under this Surety Bond may not be assigned, hypothecated or transferred for any purpose.
