Temporary Art Sculpture

INVITATION SUMMARY

The Sammamish Arts Commission is soliciting qualifications and proposals from artists interested in providing professional art services for a temporary art sculpture that will be displayed at Sammamish City Hall. The anticipated scope of work includes the design, construction, and disassembly of a temporary sculpture no larger than $10' \times 6' \times 4'$. Historically this annual installation has been made of sand, however the Commission is open to proposals of any material that is able to withstand outdoor conditions, is temporary, and will not damage the surrounding area.

SUBMISSIONS

Please submit one PDF of no more than 10 pages. All materials must be received no later than **Friday, April** 12, 2024, at 5:00 pm.

- One page artists interest in the project;

- Preliminary design and explanation of how it meets the desired theme; and

OPPORTUNITY:

The Sammamish Arts Commission seeks a qualified artist to design, construct, and disassemble a temporary art sculpture no larger than 10' x 6' x 4' to be displayed in front of City Hall for the time period of July 1 to September 30, 2024. The Commission invites all interested parties to respond to this Request for Qualifications (RFQ) by submitting their qualifications according to the instructions below.

LOCATION:

The location for this installation will be in front of Sammamish City Hall, located at 801 228th Ave SE, Sammamish, WA 98075. The highlighted area in the below image shows the boundaries of where the sculpture can be placed. This area is open to the public, and artists are welcome to visit the site.



PROJECT DESCRIPTION:

The City has previously displayed an annual sand art sculpture in front of City Hall during the summer months for the enjoyment of Plaza visitors. This year the Arts Commission has decided to open submission proposals to additional mediums. Materials are permitted so long as they do not pose a threat to the public or environment. The sculpture is expected to withstand outdoor conditions, uncovered, from July 1 to September 30th. The final installation should be no longer than 10 feet, no taller than 6 feet, and no more than 4 feet in depth.

The desired theme for this project is "25 years of Sammamish" as this is the City's 25th anniversary since incorporation. Information about the City can be found on our website at www.sammamish.us. BUDGET:

Include the total cost of the sculpture in your proposal. Projects must be at a cost no greater than \$10,000 to be eligible for consideration. This budget must cover all expenses for the project including design, fabrication, site delivery, installation, and removal of the artwork.

SUBMISSION REQUIREMENTS:

Please submit one PDF of no more than 10 pages. All materials must be received no later than **Friday, April 12, 2024, at 5:00 pm** via JotForm https://form.jotform.com/jwalzer/sammamish-temporary-sculpture.

- A written statement, not to exceed one page, which addresses the artist's interest in this project (outlining artistic motivations, interests, and techniques).
- A copy of the artist's current resume, a brief biography, web site URL (if available), and method of contact (phone and e-mail) is required. The resume should be no more than three pages of the submission.
- A preliminary design and explanation of how it meets the desired theme. Final design must be approved by City Staff and the Sammamish Arts Commission.
- Up to five samples or images of the artist's artwork.

DO NOT SEND ORIGINAL ARTWORK. Applicants are strongly encouraged to send digital information and to retain a complete copy of their application for their records. Late applications will not be considered.

EVALUATION CRITERIA:

The selection of an artist, or artists, will be based upon:

- Artistic merit of the design (Artistic excellence, creativity, and originality of the project's concept).
- Appropriateness of the design for the location, including the scale, content, and design in relation to the site.
- Originality of the design. The desired theme for this year's sculpture is "25 years of Sammamish" as this is the City's 25th anniversary since incorporation. Designs that show a connection/relationship to the City of Sammamish will be scored higher.
- Artist's qualifications. (The aesthetic quality of the artist's past work, including content, craftsmanship, uniqueness, and relevance to its environment as well as the artist's demonstrated ability to translate art concepts into durable and safe materials that can withstand long-term exposure in an outdoor environment.)

Extra consideration will be given to residents of Sammamish or the greater Puget Sound Area.

NOTIFICATION:

Artists will be notified by e-mail of the Arts Commission and City Staff's final decision. The City reserves the right to re-issue the RFQ if no qualified submissions are received. The review process will take approximately 4 to 6 weeks.

DISCRETION AND LIABILITY WAIVER:

The City reserves the right to reject all proposals or to request and obtain supplementary information as may be necessary for the City to analyze the proposals pursuant to the consultant selection criteria listed above.

The artist, by submitting a response to this RFQ, waives all right to protest or seek any legal remedies whatsoever regarding any aspect of this RFQ.
