This permit application form is used for applying for Small Wireless Facilities that meet all of the applicable criteria in SMC 21.06.060(K)(2)(a) (i). This application must be completed before construction of any Small Wireless Communication Facility can occur within the City of Sammamish.

# PERMITTING WIRELESS COMMUNICATION FACILITIES

Expedited Wireless Use Permits implicate lower levels of review time due to proposals' strict adherence with the provisions of SMC 21.06.060(K)(2)(a)(i) and the lack of the need for discretionary review by the Director.
